1. Setting of the testing and target group

This report presents the results of the 3rd NGEnvironment Partner Meeting (Foster European Active Citizenship and Sustainability Through Ecological Thinking by NGOs, 2018-1-DE02-KA204-005014).

The NGEnvironment Partner Meeting took place between the 2nd and 4th of February 2020 in the premises of SINERGIE (SIN) in Reggio Emilia in Italy. Moreover, 14 persons evaluated this meeting.

After the 3rd NGEnvironment Partner Meeting, the evaluation questionnaires were handed out to the participants, in order to evaluate and improve the quality of the program. It reflects the personal impressions of the participants about the project.

The results of this questionnaire are the following ones:

2. Quantitative data

In table 1, we can observe that most of the participants were satisfied in general with the whole 3rd partner meeting, since we cannot find any negative answer regarding this meeting. This is also shown by the results that most participants (92.9 %) totally agree that the whole training corresponded to their needs and expectations.




Figure 1: Evaluation whole meeting

Furthermore, over 92.9 % totally agree that the meeting objectives were clear (see figure 1). Even so, the item "The level of this meeting was appropriate" was evaluated positive by all participants (100.0 % totally agree). Nevertheless, most participants (over 70.0 %) think that the meeting contents were presented in an engaging way (see table 1).

Furthermore, the majority of the participants found the meeting interesting (78.6% totally agree). The coordination was well prepared (92,9% totally agree) and very helpful (100% totally agree) for the participants.

Overall, all participants were happy with the meeting results (92.9% totally agree). Therefore, we can conclude that most of the participants have a clear picture now of the projects' next steps (92.9% totally agree) and know what their tasks for the upcoming period are (85.7% totally agree).

3. Qualitative data

Furthermore, the participants have the opportunity to express their opinions on the basis of open questions. The results of the qualitative data can be seen in the following:

As you can observe in table 2, the majority of participants have no concerns regarding the development process in NGEnvironment and the quality of the management or collaboration of the project (see table 2).

Table 3 shows the answers regarding the suggestion for the future cooperation/ communication in the NGEnvironment project. Here, only 7 participants give an answer. Moreover, they indicate that there is a good and clear communication between all partners and that it should continue in this way. Nevertheless, one participant proposes to do more Skype meetings (see table 3).

The next aspect relates to Dissemination and Exploitation activities or measures the participants undertook so far to the NGEnvironment project. Here you will find a lot of activities. The most mentioned are listed below: Website, Social Media, Distribution of Newsletters, Face-to-Face Meetings, Publication in Journals etc. (see table 4).

- We performed so far dissemination activities through a combination of channels & tools, namely: Posting news on GIE's FB page; Posting project's description on GIE's Website; Presenting the project during meetings with the target groups; Distributing





printed materials about the project; publishing scientific Paper about project research.

- Posting news on GIE's FB page; Posting description of the project on GiE's web; Meetings with this target group to inform about the project outcomes; distributing printed materials; publishing scientific paper about project research.
- I've disseminated the project meeting through our social media and encourage participants of the next LTTA to do the same. We're preparing also a poster about the meeting for our website and regional newsletter.

- Our dissemination strategy has been based mainly on spreading the project developments through our network of regional stakeholders. Our region has a lot of small environmental NGOs, so it's been a great opportunity to reach their interest.

 Facebook, newsletter etc.; we started to establish closer relations with NGOs in our
 local area and build peoples engagement; We are working on publishing in local
